## New Writers Fellowship Call

**SUBMISSION DEADLINE: JANUARY 15, 2024**

The Family Process Institute (FPI) is accepting applications for the 2024 New Writers Fellowship. The fellowship supports the development of new scholars who will advance systemic theory, research, and practice grounded in a commitment to social justice. Fellows will participate in a writing workshop, *The Craft of Scholarly Writing*, taught by distinguished scholar Dr. Carmen Knudson-Martin, who has published numerous articles and books related to couple and family therapy and serves on numerous editorial advisory boards. The purpose of the workshop is to help participants shape a developing manuscript for submission to Family Process or other journals. Participants will receive both individual feedback on their work from Dr. Knudsen-Martin and small group consultation. Fellows will also have the opportunity to meet the Family Process Institute Board of Directors.

### **FPI Vision Statement:**

*Family Process Institute is an independent, multidisciplinary, transnational organization dedicated to developing and exchanging new theory, research, applied practice, and policy related to families and other systems. ## New Writers Fellowship

The fellows will participate in a writing workshop, *The Craft of Scholarly Writing*, led by Dr. Carmen Knudsen-Martin. The purpose of the workshop is to help participants shape a developing manuscript for submission to *Family Process*, or other journals. Participants will receive both individual feedback on their work from Dr. Knudsen-Martin and small group consultation. Fellows will also have the opportunity to meet the Family Process Institute Board of Directors.

The fellowship includes free tuition, two nights hotel and a \$300 stipend toward travel for the workshop which will be scheduled for the fall in Evanston Illinois. Details will be provided to the awardees. Ten fellowships are awarded each year. In order to receive the travel stipend, fellows will be required to submit a complete draft of their article to Dr. Knudsen-Martin eight weeks prior to the workshop. Guidelines for the paper will be provided.

New writers from any discipline whose scholarly interests focus on families and systems may apply. Eligible applicants include (a) students, (b) those who have earned their degree within the past five years and been the first author on no more than four articles, and (c) persons who have been working in the field for some time but are new to writing. Women and members of minority groups are encouraged to apply. Priority will be given to papers that promote social justice as a systemic issue.

## APPLICATIONS MUST INCLUDE:

- A 700-1000 word essay that includes (a) the focus and purpose of the article that you intend to write, (b) the potential of your scholarship to advance systemic theory, research, and practice grounded in a commitment to social justice, (c) current status of the project, (d) how your background and resources enable completion of the article, (e) specifically how you hope the workshop will improve your writing, and (f) your mentorship plans or needs following the workshop. Persons whose degree was earned more than five years ago should explain why they are now taking up writing.
  - Current CV
- Applications are due by **January 15, 2024**.

## APPLICATIONS WILL BE RATED ON:

- quality of the essay, including writing quality, grammar and APA style (40%)
- potential contribution to Family Process Institute mission (see below) (20%)
- potential to for essay topic to contribute to field/get published (20%)
- Social Justice component (20%)

The selection committee strives to achieve balance of disciplines, areas of interest, and social locations among the workshop participants.
